There is a special rule for real estate in Louisiana. If an ancestor gave you a gift of real estate, and you die without children, the real estate will pass back to the ancestor when you die. If you and your spouse are legally separated -- but not yet divorced -- when you die without a will, your spouse will not be entitled to your property.
